

**CHEESE UP YOUR HOLIDAY SWEEPSTAKES (“SWEEPSTAKES”)
OFFICIAL RULES**

NO PURCHASE OR PAYMENT OF ANY KIND IS NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCE OF WINNING. VOID WHERE PROHIBITED. BY PARTICIPATING IN THE SWEEPSTAKES, PARTICIPANT AGREES TO BE BOUND BY THESE OFFICIAL RULES AND THE DECISIONS OF SPONSOR’S SWEEPSTAKES ADMINISTRATOR, WHICH SHALL BE FINAL AND BINDING IN ALL RESPECTS.

1. ELIGIBILITY: The Sweepstakes is open only to legal U.S. residents residing in one of the fifty (50) United States or the District of Columbia who are eighteen (18) years of age or older (nineteen (19) or older for residents of Alabama and Nebraska) at the time of entry and have a valid U.S. driver’s license or government issued photo ID. The following persons are not eligible to participate or win: employees, contractors, directors and officers of Frito-Lay, Inc. (“Sponsor”), Propac Agency (“Administrator”), and each of their respective parent, subsidiary and affiliated companies, distributors, Web design, advertising, fulfillment, judging and promotion agencies involved in the administration, development, fulfillment and execution of this Sweepstakes, (collectively, “Promotion Parties”), and the immediate family members (spouse, parent, child, sibling, grandparent, and/or “step”) of each and those living in their same households (those persons whether related or not who live in the same residence for at least three months during the twelve-month period preceding the start date of the Sweepstakes).

2. SWEEPSTAKES PERIOD: The Sweepstakes begins at 12:00:00 p.m. (noon) Central Time (“CT”) on November 1, 2022 and ends at 11:59:59 p.m. CT on December 12, 2022 (“Sweepstakes Period”). The Sweepstakes Period is divided into six (6) entry periods (each an “Entry Period”) as outlined in the table below. Each Entry Period shall begin at 12:00:00 a.m. CT (except for the first Entry Period which shall begin at 12:00:00 p.m. CT) on the Start Date listed below and end at 11:59:59 p.m. CT on the End Date listed below. The time clock of the Administrator’s computer is the official timekeeping device for this Sweepstakes.

3. HOW TO ENTER: There are two (2) ways to enter the Sweepstakes:

(a) Purchase Qualifying Products/Upload Receipt:

Step 1: Make a Qualifying Purchase: During the Sweepstakes Period, while supplies last, purchase one (1) Cheetos® Mac 'n Cheese product (see Appendix A) and one (1) Cheetos® brand snack product (see Appendix B), **in a single transaction** (altogether, a “Qualifying Purchase”). See Appendixes at the bottom of these Official Rules for a complete list of qualifying products (each a “Qualifying Product”). **Save your receipt!**

Step 2: Register and upload your Qualifying Purchase receipt at the Website: Visit cheeseupyourholiday.com (“Website”) and follow the instructions to register and upload a scan or photo of your eligible original cash register receipt showing your Qualifying Purchase. **Limit one (1) receipt per upload. Limit one (1) entry per receipt, regardless of the number of items purchased on a single receipt.** For clarity: If you purchased two (2) Cheetos® Mac 'n Cheese products and two (2) Cheetos® brand snack products, in a single transaction, and uploaded that receipt for entry into this Sweepstakes; you will only receive one (1) entry into the random drawing corresponding to the Entry Period in which you submitted your receipt.

Receipt must show the store name, time (if included) and date of purchase, the Qualifying Products purchased, purchase prices, and receipt total. A single receipt may only be submitted one (1) time. No handwritten receipts will be accepted. **All receipt(s) for purchases of Qualifying Products must be submitted at the Website by 11:59:59 p.m. CT on December 12, 2022.** Your entry will correspond to the Entry Period in which you submitted your receipt(s). For example, if you purchased a Qualifying Product during Entry Period 1 but submitted your receipt(s) during Entry Period 2, you will receive one (1) entry into the Entry Period Drawing corresponding to Entry Period 2.

It is strongly recommended that you keep your original receipt(s) for your records. YOU SHOULD NOT CONTACT YOUR RETAILER OR SHOW OR GIVE YOUR RECEIPTS TO ANY STORE EMPLOYEE FOR PURPOSES OF PARTICIPATING IN THIS SWEEPSTAKES. PARTICIPATION IN THE SWEEPSTAKES VIA THIS ENTRY METHOD IS AVAILABLE ONLY THROUGH THE WEBSITE.

(b) NO PURCHASE NECESSARY - MAIL-IN: To enter without making a purchase, hand print your first and last name, complete mailing address (no PO Boxes), daytime phone number, date of birth, and email address on a 3" x 5" index card or piece of paper and place your entry into an outer-mailing envelope with proper postage affixed and mail it to: Cheese Up Your Holiday Sweepstakes, PO Box 2334, Addison, TX 75001. See dates listed in the table above regarding postmarked and received by dates for mail-in entries per Entry Period. Any entry postmarked in compliance with Section 2 but not received by the Mail-in Entry Received By Date set forth therein, will be entered into the next Entry Period Drawing (defined in Section 4), if any. Each mail-in entry must be mailed in a separate hand-addressed, postmarked envelope. Limit one (1) mail-in entry per stamped-outer envelope. No photocopied or mechanically reproduced entries accepted. No responsibility is assumed by Sponsor for lost, late, mutilated, illegible, incomplete, misdirected or postage-due mail or entries. Entries become property of the Sponsor and will not be returned.

No other forms of entry are valid. Proof of submitting an entry does not constitute proof of delivery or entry. **Limit one (1) entry per day per person/email address/ mailing address, regardless of entry method.** A "day" is defined as the twenty-four (24) hour time period between 12:00:00 a.m. CT and 11:59:59 p.m. CT of the same day with the exception of the first day which will begin at 12:00:00 p.m. CT and end at 11:59:59 p.m. CT of the same day.

Each entry must be manually key stroked and/or manually entered by the individual participant; automated and/or repetitive electronic submission of entries (including but not limited to entries made using any script, macro, bot or sweepstakes service) will be disqualified and transmissions from these or related emails may be blocked. If it is discovered that a participant used multiple email addresses and/or mailing addresses, or manipulated such information, for the purpose of obtaining more than the stated number of entries, such persons will be disqualified and all of their entries shall be deemed invalid and any prize won by such person shall be forfeited.

4. RANDOM DRAWINGS: Two (2) potential First Prize winners and three (3) potential Second Prize winners will be selected for each Entry Period in a random drawing on or about each Drawing Date listed in Section 2 from among all eligible entries received for the corresponding Entry Period (each an "Entry Period Drawing"). Entries will not carry forward to subsequent Entry Period Drawings; however, all eligible entries will carry forward to the Grand Prize Drawing. One (1) potential Grand Prize winner will be selected on or about December 20, 2022 from among all eligible entries received for the Sweepstakes (the "Grand Prize Drawing"). All drawings will be conducted by the Administrator, whose decisions are final in all matters relating to this Sweepstakes. Odds of winning depend on the number of eligible entries received for a given drawing. Limit one (1) First or Second Prize per person/household/email address. A winner of a First or Second Prize is eligible to win the Grand Prize.
